## LET'S TALK FLAGGING AND BARRIERS – WEEKLY SAFETY TOPIC

Flagging and barriers are used on site as a warning to personnel of hazards that exist in the work areas. Such hazards may include, but are not limited to, the following:

- An opening through which a worker could fall
- A danger to workers due to falling objects
- An ongoing hazardous operation, e.g., radiography, excavation, etc.
- A hazardous condition, e.g., high-pressure steam leak, condensate, etc.

They may provide safe walkways, crosswalks, and/or parking zones.

Whatever the purpose, they are there to protect you!

### So, what are your responsibilities when it comes to Flagging and Barriers? (hint, everyone has some)

If you are putting up Flagging or some other type of barrier:

- Know the size of the exclusion zone needed and limit or expand the barrier to provide enough coverage to keep people safe and enough room for nearby work.
- Know and understand how [SWP-6604 Flagging and Barricades](#) applies to your task.
- Communicate with those affected by the barriers so they are aware.

If you see Flagging or some other type of Barrier:

- Respect the Barrier!
- Read any tags/signage and never cross flagging without express permission of the person or crew in control of that exclusion zone.

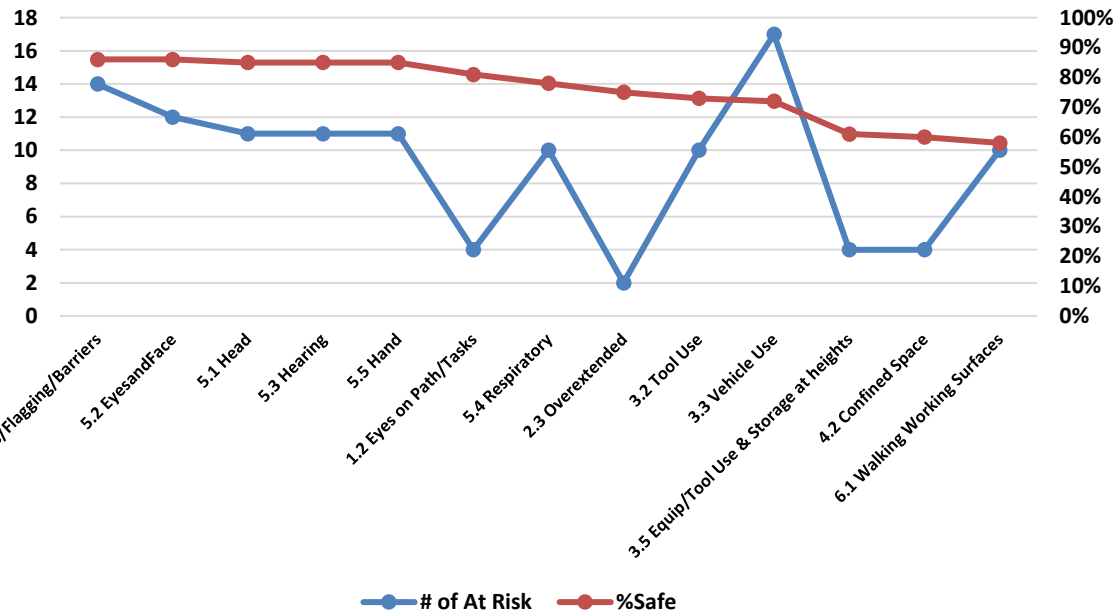

### Observed At-Risk Behaviours - Week Ending April 14, 2023



### STEP UPDATE - TOP 3 AT-RISK BEHAVIOURS:

#### VEHICLE USE

- Worker left vehicle idling while they attended their toolbox talk.
- Worker trying to spot vehicle but was unaware of proper signals or where to stand. Driver nearly hit worker.

#### WALKING/WORKING SURFACES

- Worker crossing the road in a dimly lit area. The crosswalk with flashing lights was 20 feet from where they crossed.
- Workers were walking across road with out looking up, distracted by a good conversation with each other.

#### BARRICADES/FLAGGING/BARRIERS

- 3 workers accessed a "Do Not Enter" temporary structure. Workers were unaware of the signage in place.
- Workers did not have 3D flagging and another worker descending structure ended up in the ribboned off deck.
