CHANGING CONDITIONS

With 45 +/- days in, we have become someone accustomed to a “zero energy” environment, with understandably, a significant reduction in perceived risk, due to the preparedness and state of equipment we have been working on.

This is changing and the focus now must be turned to and include a “charged energy state” or that of a unit/equipment coming back online. All associated equipment will soon be under pressure, contain gas or hydrocarbon liquids, temperatures will be increasing to extreme operating ranges, toxicity levels will be increasing beyond UEL’s at times.

The serene working environment that has been the norm through Turnaround, will now be filled with new sounds, odors and activities that have been in submission for the past little while.

Operations field personnel will be engaging in their pre-start up activities, which may cause a sense of alarm to those not accustomed to those sights such as operations wearing SCBA for checks and measures, sampling, or for a hastened response due to some malfunction.

At this time, it is of paramount importance, that we all change our mindsets, focusing on performing tasks on a preparing to run/almost running unit. The risks and hazards are completely different, and any lapses, misinterpretations, misunderstandings, poor judgment, or decisions, could potentially develop

into a catastrophic result.

Hazard identification and appropriate controls for tasks being performed during this phase, along with key timely communications are the best proactive preparation.

Additionally, we also need everyone to be completely focused and report if leaks or unusual odors develop, unusual sounds are created, etc. Do not hesitate to contact operations so that an escalation of any event can be prevented.

Take the time to think things out, develop a plan and clarify before starting any work and as always look out for one another.

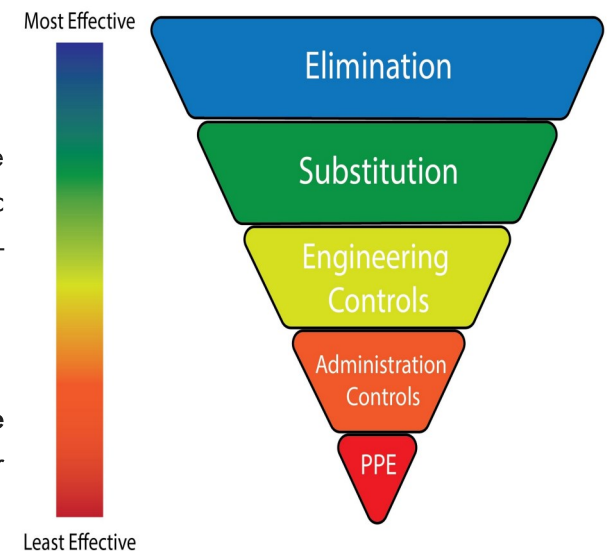
